

LAPEER COUNTY RETURNS TO "APPOINTMENT ONLY"

PROTOCOL AT

LAPEER COUNTY COMPLEX & ANNEX BUILDINGS
EFFECTIVE NOVEMBER 18, 2020

The Lapeer County Court/Complex and Annex Building doors will be locked and services will be available by **"APPOINTMENT ONLY,"** however, the courts and county offices are **OPEN** for operations.

We recommend you preschedule an appointment by calling the office you need in advance. **When you arrive, review the [Department Telephone List](#) posted on the front doors and CALL the office and someone will assist you.**

Please call the appropriate office to preschedule an appointment (or once you arrive) during normal hours Monday through Friday, 8:00 a.m. – 5:00 p.m. *(Some office hours will vary so please **See Department Telephone List** and ask for their hours of operation).*

If you arrive for a PPO, Court, or Hearing proceeding, please call the Court Office to let them know you are here and staff will escort you to the proceeding and back out of the building.

All individuals entering the County Court/Complex or Annex for their appointment will be **REQUIRED TO WEAR A MASK** and **COMPLETE THE SELF SCREENING FORM (available at the entryway)** after being authorized to enter (no exceptions). **If you arrive and need a MASK or are uncertain which office you need, please call (810) 667-0366.**



*We strongly encourage EVERYONE to make every effort to utilize County services via Online, Over the Phone, US Mail, or DropBox located in the front of the building if you can avoid coming into the buildings.
